Subject: Submission of Supporting Evidence for BEAD Funding Exemption

Dear ULFW Provider,

Thank you for notifying the Arizona Commerce Authority of your intent to submit supporting evidence indicating that BEAD funding is unnecessary for the locations you serve in accordance with the recent federal amendments to the BEAD program outlined in the [BEAD Restructuring Policy Notice](#) dated June 6, 2025.

This message is a reminder that you have seven calendar days from the date of this notice (June 20, 2025) to provide the required documentation supporting your claim that your existing ULFW services meet the technical and service standards necessary for a BEAD subgrant.

The Arizona Commerce Authority requires that the ULFW provider submit the following supporting documentation to proceed with your claim that BEAD funding is unnecessary for the locations your services cover:

### 1. Locations and Capabilities

- Provide a detailed list of BEAD-eligible locations supported per tower, with a focus on the following needs:
  - Basic Requirements:
    - ✓ Minimum 100 Mbps down and 20 Mbps up during peak times.
    - ✓ 100 msec of latency.
    - ✓ Evidence showing these speeds are maintained during peak times.

### 2. Frequency Spectrum Usage Per Tower

- Provide the frequency spectrum(s) utilized per tower.
- Describe the capacity offered per sector under various interference conditions:
  - Line of Sight (LOS)
  - Non-LOS
  - Different inclement weather conditions
- Detail different equipment configurations, such as signal strength and additional reserved capacity to meet the committed speeds and latency requirements:
  - During interference conditions
  - During non-interference conditions

- Provide this analysis in a standard polygon GIS format that represents the propagation model / coverage of each Tower

### 3. Interference Mitigation

- Provide evidence of how interference mitigation is executed to maintain the committed speeds.
